Our program is aligned with the Maryland Teacher Technology standards, and all indicators are embedded in the various modules of our Teaching Institute. Our typically hybrid instruction model means that all students illustrate daily the ability to use a variety of technological formats to communicate and to create and deliver instruction. Training is provided in use of classroom technology specific to the MCPS classrooms as part of each class meeting of the Teaching Institute, and candidates use this technology in delivering their sample lessons. This technology includes the use of classroom response systems which allow teachers to assess students immediately in a formative way. During the module on assessment, candidates learn to review and analyze typical testing and performance data for the MCPS student, and consider action steps for enhancing performance. During the resident teacher seminars, each candidate designs, conducts, and prepares a presentation on an action research project, which includes an illustration of their data collection and management tools
