Subject: Notice of Non-Discrimination and How to Report Concerns

Montgomery College is committed to creating a safe, welcoming, and inclusive environment in our educational program.^[1] We know that experiencing discrimination can make it harder for students to succeed and reduces the sense of belonging we seek to create. This memo includes key information about our commitment to creating an environment free from discrimination. It also includes important resources for reporting concerns.

Nondiscrimination Notice

The College prohibits discrimination against any person on the basis of age, color, citizenship status, current or former military status, disability, gender, gender identity and expression, genetic information, national origin, marital status, race, religion, sex, or sexual orientation. Sex-Based Discrimination

Understand the law. In accordance with Title IX of the Education Amendments of 1972, Montgomery College prohibits sex discrimination, including sexual misconduct^[2], and sexual harassment. These protections also extend to students experiencing pregnancy and related conditions.^[3]

Know when to reach out. Students who believe they have experienced sexual harassment, dating violence/domestic violence, sexual assault or stalking should contact the Title IX office. Once connected, students can receive supportive measures, like counseling or No-Contact orders, and learn about options for filing a formal complaint with the College. Assistance with connecting to community-based resources, like local law enforcement, is also available.

What if I am pregnant? Students experiencing pregnancy and pregnancy related conditions are entitled to adjustments to support their continued access to the College's educational program. Disability Discrimination: What if I have a disability?

Understand the law. In accordance with Section 504 of the Rehabilitation Act of 1973 and Title II of the Americans with Disabilities Act as Amended (ADAAA 2008), Montgomery College prohibits discrimination based on disability in its educational programs and activities.

Apply for Accommodations. Students seeking accommodation for disabilities are encouraged to contact Disability Support Services (DSS) to begin the process. Visit [Disability Support Services](#) to learn more.

- **Speak up if something seems wrong.** Students who are concerned about how faculty or staff are implementing their accommodations should reach out to their DSS counselor to attempt an informal resolution to correct the problem.

- Religious Discrimination: What if I need to miss class to participate in a religious event?

- **Understand the policy.** It is the College's long-standing policy and practice to provide reasonable alternative academic accommodations for students to practice sincerely held faith-based or religious beliefs.

- What if I feel like I am being discriminated against based on my race, color, ethnicity, age, or other protected status?

Know that you have options: You can report your concern to the College. After submitting your complaint in writing and participating in an intake, you will receive information about your options.
